1 **ORDER**

2 For the reasons set forth in the parties' stipulation regarding the form and
3 manner of class notice in this case, the Court hereby approves the parties' proposed
4 form and manner of class notice. The proposed form of notice will properly apprise
5 class members regarding the relevant issues relating to the case, and the proposed
6 manner of notice, *i.e.*, a request by the NCAA to its member schools that personal
7 distribution by mail with plaintiffs bearing the actual costs of first class postage and
8 copying charges (or, alternatively, distribution by the claims administration firm
9 identified by plaintiffs at plaintiffs' expense) be made to the last-known address
10 campus (for current students) or off-campus (for former students) address of each
11 individual class member that the relevant colleges and universities are reasonably
12 able to identify, is the best means practicable for providing class notice in this case.
13 If the parties learn that this manner of notice is not possible, the parties will report
14 to the Court regarding the efforts to provide notice to the Class and any additional
15 forms of notice that may be required.
